Pursuant to the Executive Order, and to maintain the orderly conduct of the meeting, the Napa/Solano Area Agency on Aging will allow Board members and Council members to attend the meetings telephonically and to participate in the meetings to the same extent as if they were present.

For members of the public who wish to participate, but not to attend telephonically, you may submit written comments on any matter within the Board or Council's subject matter jurisdiction, regardless of whether it is on the agenda for Board or Council consideration or action, and those comments will be entered into the administrative record of the meeting. ## Amendment 3 to the Area Plan – One-Time-Only (OTO) Expenditure Plan \$63,339

#### 2.9.22

California Department of Aging released Amendment 3 to the Area Plan. Included in the Amendment is OTO funding – this funding:

- Must be allocated to current providers
- Cannot be moved from one category to another
- Must be fully expensed by June 30, 2022

Breakout is based on JEPA: 25.81% for Napa and 74.19% for Solano.
