Solano ADRC continues to serve Solano County residents with referrals to resources.

## California Area Agency on Aging Conference Highlights

Ashley Cumpas and Gwendolyn Gill attended the California Area Agency on Aging Conference (C4A) where AAA agencies on Nov 5-7, 2025. Highlights include:

- Dr. Norma Lisenko -Innovative Health Solutions - gave an excellent presentation on the Bistro program at the Benicia Senior Center
- The future of services for seniors and people with disabilities will be challenged with the federal and state changes in funding for health care and an array of programs.
- California is working diligently to mitigate losses of programs.
- Our AAA safety net of services matters. Coordinating our services and establishing more partnerships will be important to navigate in this new arena.

## Senior Nutrition Service Needs

Over the last few months, there has been a growing demand for home delivered and congregate meals throughout both counties. We have been using our ADRCs to direct clients to alternative food resources such as the

Community Action Napa Valley, Food Bank, Food is Free, and other community organizations.

### **Additional NSAAA Service Provider Funding**

The California Department of Aging allocated the NSAAA one-time only designated funds in certain service categories for 11 service providers in November 2025. These contract amendments were completed in November-December 2025. There are two amendments pending in January 2026.

### **Board Items**

The Solano County Board of Supervisors will hear two items in January 2026:

- January 6, 2026 – Food is Free to receive \$71,419 to provide grocery bags to older adults through June 30, 2026.
- January 13, 2026 - Innovative Health Solutions to receive \$78,284 to support sustainability of the Cal-Fresh Education and Outreach program before sunset March 31, 2026.

### **Senate Bill 707 - Update on Brown Act**

“Open and Public VI: A Guide to the Ralph Brown Act” Booklet sent to all ACOA members. Details about the bill’s implementation are still being clarified. The initial step was sending out this booklet.

Our meeting rooms in Napa and Solano Counties have video-conferencing capabilities. Our meetings can be hybrid meetings – both in person and virtually.
