California Governor Gavin Newsom issued Executive Order N-25-20 on March 12, 2020, relating to the convening of public meetings in light of the COVID-19 pandemic. The Napa/Solano Area Agency on Aging hereby provides notice that it will continue to convene its regularly scheduled public meetings of the Oversight Board and the Advisory Council telephonically, as provided in the publicly posted agenda notice, and until further notice. Pursuant to the Executive Order, and to maintain the orderly conduct of the meeting, the Napa/Solano Area Agency on Aging will allow Board members and Council members to attend the meetings telephonically and to participate in the meetings to the same extent as if they were present.

For members of the public who wish to participate but not to attend telephonically, you may submit written comments on any matter within the Board or Council's subject matter jurisdiction, regardless of whether it is on the agenda for Board or Council consideration or action, and those comments will be entered into the administrative record of the meeting. Staff Report October 4, 2022

1. CA Aging for All Conference Highlights

The meeting focused on the progress of the Master Plan for Aging. Key principles are: Engage, Embed, Launch, Focus, and Implement.

California is

- #41 in poverty for people ages 65+
- #41 in voters over the age 65 67% of people who vote are over age 65
- #49 for severe housing problems
- #2 longevity live an average of 81.5 years

Need 5% increase annually to keep up with current funding for aging services -- Senator Pan

Need to create path for middle class to receive LTSS

Equity needs to be "baked in, not sprinkled on" – Rigo It is not just about inclusion, it's about being invited... -- Ghaly

Advocacy -

- Tell legislators, whatever you do is going to affect 25% of the population
- Start one-on-one conversations now need to educate staff and legislators about the issues and the ask. Why it is important
- Never has there been so much turnover in state legislators.
- The most organized proposals get done
- Never give up may take 5-10 years but keep asking

3. American Rescue Plan Contracts

Oversight Board approve contract recommendations Contracts are in process – will take 2 months to execute

4. Staff Changes

Administrative Assistant -- Jaquetta Jefferson is the new Administrative Assistant for the AAA – YEAH!!! She will be focused on data reports, contracts, and miscellaneous administrative duties. So excited!!!

Fiscal – Jay's position as Staff Analyst has yet to be filled – probably 3 or more months. **Accounting Clerk** – Maria, who helps with claims processing, will be out on maternity leave at the end of November. Another person will fill in while Maria is out.

Contracts - Christine retired, and Paisley is taking over



5. Provider Updates

Line Dance Pilot - The state-wide Line Dance curriculum creation pilot continues under the direction of Innovative Health Solutions.

CalFresh Expansion – this contract is resuming after a 2-year hiatus due to the pandemic. The Food Bank of Contra Costa and Solano is leading the outreach effort to help older adults sign up for CalFresh benefits. Contract is in process and will be completed within the next 2 months. Funding is ongoing for at least 3 years.

Senior Nutrition --- Annual survey and program audit are completed. Stella WuChu, AAA Nutritionist, completed the review. Attached are the highlights. The results are generally good. The findings are being addressed and are minor.

Empowered Aging – Major staffing changes have caused some temporary program issues – nothing affecting clients directly. The organization recently hired a Director of Programs. I anticipate services to continue.

Share the Care Napa Valley – Executive Director resigned for a position with the County of Napa. The search is on for a new Executive Director.

Meals on Wheels Solano – Executive Director will be operating remotely going forward. I do not anticipate any service disruptions.

Collabria Care - Leading work on a 15-month process including focus groups and surveys to create a detailed strategy to support the aging community in Napa County for the next 10 - 15 years.

Caregiving Goal

In What Way Might We:

Determine the feasibility of developing a student volunteer program in three high schools and the Community College in Napa County.

That would result in:

A "senior helper" type program matching student volunteers with frail seniors who need occasional assistance on various projects which would enable the senior to remain living independently.

Overview

High school and college students in the Napa and Solano Counties will be matched to seniors in the community to provide help as needed to the seniors.

The students would earn service hours for credit towards their graduation service requirements.

This can be accomplished by:

- 1) Set up a high school "community credit" program with the proper department at the 3 high schools to help seniors with shopping, errands, yard care, dog walking, etc.
- 2) It will happen as a result of the ACOA coordinating helping to set it up with the proper school department. The schools will maintain it, monitor, etc. We can help set it up, and connect the counselor office or department with names/needs of seniors who need help in some form. The students receive community service credit, which they need for high school graduation.
- 3) Tools, resources (our connecting students with seniors through a school personnel, and methods as described above.

AAOA Technology Goal

In what way might we create a list available to older adults in Solano County of free /low-cost classes and resources for using electronic devices.

This would result in the compilation of a single resource that is printable, can be added to the ACOA web site as well as other government and nonprofit sites, and can be used by county and nonprofit organizations, a resource that can be readily emailed to older adults and their families. Such a resource will significantly increase ready access to training opportunities throughout the county.

We believe there are several problems at present, one of which is the inability (intimidation factor) of seniors to fully utilize tools that they may already have. Awareness of community-based locations of training may help minimize the real and perceived barriers older adults have related to technology usage.
