Napa/Solano Area Agency on Aging. The Council itself is comprised of sixteen members, half representing each county, appointed by the respective Boards of Supervisors.

Advisory Council – Applications Being Accepted

The Napa/Solano Area Agency on Aging, one of thirty-three similar organizations throughout California, is a comprehensive and coordinated service system focused on improving the lives of older adults, persons with disabilities, their families, and caregivers. Its current four-year Area Plan established four priority areas: improving health outcomes; reducing social isolation; raising nutritional awareness and services; and enhancing community-based, long-term services and supports.

Supporting the work of the Napa/Solano AAA is an Advisory Council, comprised of sixteen members, eight from each county. Council members are appointed by the respective Board of Supervisors and are charged with (1) advising the AAA on funding and service priorities, (2) assisting with provider performance reviews, and (3) advocacy. As advocates for older adults, Council members are expected to be informed about key legislation and issues facing the older adult population locally, voice their concerns with elected officials, and inform and gather support from other community members.

The Advisory Council meets on the first Tuesday of the month from 10 am to 12 noon. Meetings alternate monthly between Napa and Fairfield. The monthly time commitment averages 3-5 hours. The Council is currently seeking qualified applicants to fill several vacant seats in Napa and Solano counties.

iPad distribution

Older adults at risk of social isolation and who don't already have an internet connected device and cannot afford to purchase a tablet to connect with family, friends, or telehealth appointments, may be eligible for a free device.

Devices are limited to older adults (60+) or adults with permanent disabilities who are at risk and do not have access to a device. Those interested should contact the Aging and Disability Resource Connection at (707) 200-7116. Callers need to leave a message so an intake coordinator can return the call and administer a brief intake questionnaire to determine if the person is eligible to receive a device. Devices are reserved for the most at-risk individuals as numbers are limited.



GIS Story Maps

Public Works Utilities Division recently launched two GIS Story Maps to help educate residents on where they can safely dispose of used oil and batteries. Story Maps are powerful online maps that incorporate graphics, text, photos, and special functions to help users explore content in an interactive, easy-to-use fashion. The Used Oil Story Map shows all the locations within the City where residents can safely dispose of used motor oil at certified collection centers. The page also provides information about the importance of recycling used oil.

The Battery Recycling Story Map lists all the locations where residents can access battery recycling boxes for small battery disposal, as well as information on how to dispose of larger-capacity batteries.

Story Maps like these are an effective way to reach and educate residents about the importance of proper material disposal and environmental protection. The used motor oil map is available [HERE](#).



I met my friend Ben a little over two years ago as a volunteer with Empowered Aging's "Friendly Visitor" program. The program was designed to provide a way for isolated older adults to stay connected to their community, even with a weekly phone call. Remember, this was right in the middle of COVID, and the older adult population was getting hit hard. As a volunteer, my "job", and it seemed like a job at the time, was to call Ben every Wednesday, conduct a conversation and, over time, develop a friendship that has proven mutually rewarding. The Night I Met Cool Poppa

I graduated from Yale in 1973 with a BA in hippiedom (officially in Philosophy and Psychology). For most of my time there, I lived on a 40-acre farm 15 miles outside of New Haven, Conn., with a group of students, friends, chickens, turkeys, goats, a cow, a pig, and a horse. As a part-time job, I worked at the local record store, absorbing as much jazz, blues, and soul music as I could.

I had started playing the harmonica the summer after high school after hearing a commercial on the radio from Hohner, the world's biggest harmonica maker, extolling the virtues of harmonica playing for young men who were interested in becoming more successful with the ladies. By the time I attended Woodstock in August, I was well on my way—with the harmonica and the ladies. I continued improving while at Yale, playing with other musicians and became quite good. By 1971 I began to frequent the black neighborhoods of New Haven, playing my harmonica at jam sessions with my friend Danny Bittker, learning to solo over jazz and blues changes laid down by an organ trio, which consisted of a Hammond organ player who played the bass with his foot pedals, a guitarist, and a drummer. Other musicians, singers, trumpet and sax players, guitarists, etc. would line up for the chance to take their solo with the house band. [Read what happens next HERE.](#)

Oral Health for Older Adults in California

Oral health affects overall health – and this is particularly true for older adults. Yet, access to oral health treatment is limited and complicated by factors such as lack of dental coverage, complicated rules, and lack of dental providers. **This webinar, [Oral Health for Older Adults in California](#), will assist advocates in connecting their clients with oral health treatment.**

This webinar will provide a summary with advocacy tips on the following topics:

- Why oral health matters
- The state of oral health for older adults in California today
- Health insurance coverage options for older adults including Medicare, Medi-Cal, and other forms of coverage
- Unique barriers sub-populations of older adults encounter in accessing oral health, including dual eligibles and nursing facility residents
- Treatment alternatives for individuals without dental coverage

Meals on Wheels

Lunch at the Senior Center

Although a lot of older people remain hesitant about being in an enclosed, indoor space due to our three-year experience with COVID, there are clear signs that folks who've been isolated in their homes are increasingly eager to venture out in public again and socialize with others. **Meals on Wheels** provides opportunities for older adults 60+ to enjoy and share lunch with friends and neighbors at a local Senior Center. The goal of the lunch program is to make sure older adults are provided with nutritional food.

To make lunch reservations:

For your convenience, included is a listing of all Senior Centers in Napa and Solano County that offer congregate lunches, along with the dates and times of the meal.

The Senior Centers are ramping up their social activities and events; be a part of it by joining friends and neighbors for a luncheon dining experience sponsored by **Meals on Wheels**.



If you are setting up long-term services and support; your local Aging & Disability Resource Connection (ADRC) has four core services you can draw upon to help you reach your goals.

Enhanced Information and Assistance (EI&A): Highly visible and trusted call centers with an online, comprehensive, searchable database, quickly identify which needs are most pressing and connect you to the appropriate Critical Pathways Providers. EI&A uses warm transfers and follow-ups to make sure your needs are met.

Options Counseling: An interactive process where individuals receive guidance in their deliberations to make informed choices about long-term supports. Plan for your future care needs with Case Manager/Navigators or Independent Living Peer Counselors.

Short-Term Service Coordination: Assistance to older adults and people living with disabilities who urgently need help with multiple services and programs for 90 days or less.

Transition Services: Individualized Hospital-to-Home or Nursing Facility-to-Home transition services.

Mobile Crisis Unit Solano

Recognizing the need for mental health specialists to respond to some emergency calls, Solano County Behavioral Health has joined forces with Pacific Clinics to expand the Mobile Crisis Response Program. The specialized Mobile Crisis Unit responds to mental health emergencies.

The program can be accessed by calling 911, where police department emergency dispatchers handle the calls from 11 a.m. to 10 p.m. Mondays through Fridays. The program's mission, according to the county officials, is to de-escalate crisis situations, link people to necessary services, and support the care coordination with appropriate agencies.

Need a ride to the doctor?

You can now get a ride to and from your doctor visits at no charge. As a Kaiser Permanente Medicare health plan member, you can get a ride to and from your appointments at no cost. Your plan covers up to 24 one-way trips (50 miles per trip) per calendar year.

To schedule a ride for rideshare, taxi, or private transportation service, call 1-877-930-1477 (TTY 711). You can also schedule online at [medicaltrip.net](https://www.medicaltrip.net) or download the MTM Link Member app. To download the app on your device, visit the App Store (Apple) or Google Play (Android) and search for MTM Link Member App.

For wheelchair van or gurney van transportation service, call 1-833-226-6760.

Request your ride at least 3 business days (Monday through Friday) before your appointment. If you have an urgent last-minute appointment, call as soon as you can.

You can get rides for doctor appointments, medical services such as lab or X-ray, and picking up medications or medical equipment.

Benicia Lyft rides



Benicia Lyft rides

The Solano Transportation Authority (STA) will pay a portion of your Lyft rides throughout the City of Benicia, and to Springtown Center in Vallejo. These rides are valid only to specific destinations and between the hours of 6am-9pm for Benicia residents. To qualify you must be an older adult (65+), a veteran, or ADA eligible.
