- 1. Received budget update and fiscal matters Gina Garcia, Fiscal Analyst
 - FY2324-(as of 6/30/24) Monthly Fiscal Report-PP presentation Gina
 Garcia

Gina Garcia -stated that much of the Area Plan allocations are unspent by providers, but providers have been contacted. Joelle Gallagher: inquired about the low amounts. Elaine Clark: stated that the family caregiver service provider's do not claim until the third month. Redwood Caregivers allocates client hours and the client usually saves some of their hours for later in the year, so that they are not depleted. Elaine Clark: More monies will be received for the CalFresh Healthy Living program since we were asked to create a garden curriculum that includes a meal component. Also, we receive the most funding because we did so

well with adding the line dancing. **Gina Garcia**: concurred that more funding will be received. **Joelle Gallagher**: inquired about whether the funding will also include for outreach opportunities. **Elaine Clark**: responded with no, since it is thru the Farm Act, they are very specific about how the monies are to be used. **Gina Garcia**: continues to present about emergency assistance funding **Elaine Clark**: stated that the leftover monies from Benicia will be reallocated.

- 2. **Elaine Clark:** 6 -year Highlight Presentation and recognition of Oversight Board members whose terms have expired.
 - Elaine Clark-played a game that included all the highlights over the past six years and expressed appreciation for all that the board members accomplished via outreach, etc. Elaine Clark: informed the Board of meeting dates for fiscal year 2025/2026 and requested feedback on how to improve going forward. Monica Brown: suggested teaching seniors how to use cellphones/apps., etc. Elaine Clark: Mentioned that Stewart Bruce wrote a grant for educating and training on devices. The results may be received in Jan/Feb 2025. Also, we are working with Yolo County (Cecelia Aguiar Curry's office) on legislative changes that would allow AAAs to purchase and distribute electronic devices without ongoing tracking. The state's requirement is that if it has memory, it must be tracked.
