Board Member Comments

- Steve Sillen asked if there were services available to assist seniors with emergency bills and if a senior needed someone to review their home to tell the senior if changes should be made for safety reasons. Elaine Clark said both Napa and Solano Counties have providers in place to assist.
- Joelle Gallagher asked about ARPA funding allocations. Elaine Clark agreed to send the approved allocations to the Oversight Board.
- Ronald Kott asked if staff thought our service providers would use all their
 allocated funding before each contract ends. Both Girlie Jarumay and Elaine
 Clark stated that we anticipated coming close, that services were being provided
 and both Fiscal staff and Program staff were following up with providers to assist
 and encourage them to submit invoices. Staff commented on the number of
 contracts with each provider and how difficult it was this year to submit invoices
 for the services while being mindful of expiration dates for different contracts.
- Steve Sillen asked if the AAA has outreach materials to use when meeting with groups. Elaine Clark said we have the Resource Guides. The Board asked if the AAA could purchase small items to give to community members as well.
